Evidence for transgender as a social contagion.

Until 20 years ago, the frequency of transgender individuals was about 1/10,000. That would be about 400 in a US birth cohort of 4 million.

According to a Gallup poll (Feb 17, 2022) the occurrence in the generation Z cohorts reaching 18 years of age (18-23) has reached 2%. That's an increase of 200 times (from .0001 to .0200). That would be 80,000 new transgenders people per birth cohort.

If, as some advocates claim (The Trevor Project), removal of repression and oppression is what allows true transgender and bisexual individuals to emerge, why haven't the Boomer and Generation X numbers increased notably (Gallup poll, Feb 17)? It seems that repression decreasing isn't as powerful as is the internet and school grooming. And the numbers are just too radical. A change in frequency of 150 (Pew poll June 2022) to 200 times is not likely to be due only to removal of repression and oppression. Social contagion is more likely. 40-50 year old women are not now discovering that they are really men.

It does take an egg and a sperm to initiate a life for the next generation. There has been no other way for mammals to reproduce for something like the last 200 million years. Being transgender tends to interfere with all social interactions, including family formation and sexual reproduction. Thinking in evolutionary terms: that natural selection would make transgender genotypes and developmental errors to be quite rare.

Males who transition later in life often succeed in reproducing: Richard/Rachel Levine (2 children), Bruce/Caitlin Jenner (6), James/Jan Morris (5), but the transgender individuals of today tend to be manipulated into transitioning at younger ages and to be female. The "medical" interventions possible today, while not bodily fatal, often risk being genetically lethal, preventing or inhibiting reproduction. This is especially true for females in part due to their shorter reproductive window. Alarmingly, trans activists claim that a Princeton study of 317 children, trans at 5 to 12 found 97% still trans 5 years later. No subject had reached adulthood. This attests to the power of "affirmative care" since 61 to 98% without "affirmative" "care" go back to identifying with their biological sex.

Twenty years ago and historically, transgender individuals were 2:1 male. This makes biological sense because the female body plan is more basic due to being more rigorously selected for the survival of children. Anything that goes wrong with the male developmental plan leaves the possibility of the female plan substituting. Today, transgender individuals are 2:1 female. This does not fit biology.

Increases in LGBTQ individuals from 2.6% of the Boomer generation to 20.8% of the Z generation shows huge increases in transgender and bisexual individuals, while homosexuals (gay & lesbian) increase much less (Gallup poll Feb 17). Bisexuals may be adventuring a bit, while remaining cisgender. If they are found paired or living with someone, it is a person of the opposite sex. Yet they gain the privileges now accorded to the LGBTQ group.

The transgender increase is disproportionately driven by the more radical changes that females undergo during puberty. Their bodies and social roles change far more during puberty than do the bodies and social roles of males.

It's a much tougher transition for females. Adolescent girls are subject to social contagions and clique driven behaviors. A fad right now, supported by the internet and its biases, and by many schools, is transgenderism. The Davis Unified School District (Davis, CA) reports 4 to 6% trans students.

There is profit in promotion of transgendering for morally challenged medical providers. This is especially so if children begin transition at younger ages, because they are more likely to continue transitioning and they will most likely need medical interventions for the rest of their lives. The counseling/shrink industry has been wrong before: remember recovered memories?

To summarize: The evidence that over 95% of today's transgender individuals are not really transgender includes:

- 1. The raw number, increasing from 1 in 10,000 to 110 to 200 in 10,000, over a 20 year period. This is mirrored by increases in surgical interventions.
- 2. The shift from emergence in young children to adolescents.
- 3. The shift from mostly males to mostly females
- 4. Lack of large increases in Boomers and Generation X transgender numbers, despite transgender becoming a privileged group.
- 5. Social disdain is now much less, the internet provides selectively positive views of transgendering, and schools often introduce the idea that the transgender condition is frequent and is to be granted special privileges.
- 6. In roughly 20 states (incl. CA) it is not even legal to counsel a child towards his or her biological reality, but only away from it. Truly informed consent cannot occur.
- 7. UK National Health Service research shows hormone "treatments" unhelpful and advises doctors not to encourage name changes, hormone treatments, or surgeries as young people are going through a phase.
- 8. The New York Times is (since April 2022) publishing occasional articles carrying criticisms of the transgender phenomenon (NR March 20, 2023).
